Do you know, what you need to know
about your license

General Information:

CE Law went into effect April 4, 1983

CE Requirements: Resident Insurance Producers must get:

Sixty (60) hours of CE instruction are required prior to one's initial license renewal date.

Forty-five (45) hours of CE instruction are required prior to all subsequent license renewal dates.

9/17/14...Licensing as you knew it changed!

* 3 Hour Ethics approved course must be completed
for each renewal cycle.

- Enter the 7 digit License Number and the first three characters of the last name for each of the Producers whose transcript you wish to retrieve.

If you have completed more than 20 courses during the triennium, the transcript will only display the 20 most recently completed.

You are responsible for retaining certificates of course completion as evidence of credits earned.

If you do not comply....

If you do not comply with the continuing education law, the Division of Insurance may suspend your license pending completion of your CE requirement and/or you may be subject to a civil fine of not less than \$20.00 nor more than \$100.00 for each hour of instruction you fail to complete.

Reporting Timelines changed too... what does that mean to you?

We HIGHLY recommend that you get your CE credits done at least 30 days prior to your license renewal date (your birthday) to ensure they are posted correctly to your Prometric record.

As soon as the DOI's technology is in place, if your CE is not posted, you will not be able to renew your license. The credits will have to be posted to your Prometric account to renew your license.
